CONSIDERATION OF THE MINUTES OF THE OCTOBER 11, 2021 REGULAR FINANCE COMMITTEE MEETING

Following brief discussion:

*** S. Skoczen moved, F. Buhrman seconded, that the Committee accept the minutes of the Regular Finance Committee Meeting of October 11, 2021, as submitted. Motion passed unanimously.

OLD BUSINESS

There was none.

NEW BUSINESS

2022 2nd Quarter Financial Review:

Mayor Harris opened discussions by complementing the Borough Manager and staff on the early payoff of the Municipal Building Mortgage. Members questioned the source of funds and the continued financial health of the Borough. Mr. Hazlett explained that unreserved cash had been saved over the past several years for this purpose. Capital Reserve funds are intact, general operating funds were not used and the ARPA funds were not used.

Mr. Hazlett provided an overview of the budget; when asked if he had any concerns, inflation and salary increases due to the volatile work market and increased inflation were discussed. The 2023 budget process will address these issues.

- o # 04-367-203 Approximately \$700 income over expenses for Daddy/Daughter Dance
- o # 04-367-210 All six (6) Movies-in-the-Park sponsored this season
- o # 08-429-280 Over budget due to purchase of new dialer for plant
- o #21-471-416 Payoff of Municipal Building Mortgage
- o #30-454-651 Over budget due to Pavilion Remodel (2021 project completed in 2022)
- o #30-430-740 Over budget due to 2021 purchase of Loader delivered and paid for in 2022
