- Section §11-109., "Fire Safety Requirements"
 - o Section A Add Smoke Detector
- Section \$11-110., "Inspections, Licensing, and Enforcement"
 - O Section B Replace the current verbiage with the following: "The Code Enforcement Officer shall inspect each Rental Property in the Borough to determine compliance with this chapter once every two years pursuant to a reasonable schedule to be established by such officer or in response to a complaint that an alleged violation of the provisions of this chapter or of applicable rules or regulations pursuant thereto has been committed, or when the Code Enforcement Officer has a valid reason to believe that a violation of this chapter or any rules and regulations pursuant thereto has been

committed, or upon the change of tenant or transfer of ownership of the entire property."

- Section §11-117., "Inspection, licensing, and cancellation fees"
 - o Section A Change "annual registration fee" to "bi-annual"
- The following fees were discussed:
 - o License
 - o Initial Inspection
 - o Inspection (Annual or Biannual)
 - o Re-Inspection (If issues are found)
 - o Interim Inspection (Change of Tenant)
