**Part 1****General Regulations****§15-101. Definitions and Interpretation.**

1. Words and phrases, when used in this Chapter, except for Sections or Parts to which different or additional definitions apply, shall have the meanings ascribed to them in the Vehicle Code, the Act of June 17, 1976, P.L. 162 No. 81, as amended, except that, in this Chapter, the word “street” may be used interchangeably with the word “highway,” and shall have the same meaning as the word “highway” as defined in the Vehicle Code.

2. The term “legal holidays” as used in this Chapter shall mean and include: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day.

3. In this Chapter, the singular shall include the plural, the plural shall include the singular, and the masculine shall include the feminine.

4. Although the streets in the Borough of Carroll Valley run generally in a northeast-southwest and a northwest-southeast direction, for the purpose of this Chapter, Pa. Rt. 116 and the streets running parallel or generally parallel to Pa. Rt. 116 shall be deemed to run in a north-south direction, and Skylark Trail and the streets parallel or generally parallel to Skylark Trail shall be deemed to run in an east-west direction.

**§15-102. Manner of Adopting Permanent Traffic and Parking Regulations.**

All traffic and parking regulations of a permanent nature shall be enacted as ordinances, as parts of ordinances, as amendments to ordinances, or as amendments to this Chapter, except where the law specifically authorizes less formal action.

**§15-103. Provisions to Be Continuation of Existing Regulations.**

The provisions of this Chapter, so far as they are the same as those of ordinances and regulations in force immediately before the enactment of this Chapter, are intended as a continuation of those earlier ordinances and regulations, and not as new enactments. Nothing in this Chapter shall affect any act done or liability incurred, or any suit or prosecution pending or to be instituted under any of those repealed or superseded ordinances or regulations.

**§15-104. Temporary and Emergency Regulations.**

1. The Mayor shall have the following powers to regulate traffic and parking temporarily and in time of emergency:

A. In the case of fire, flood, storm or other emergency, to establish temporary traffic and/or parking regulations.

B. In the case of emergency or to facilitate public works, or in the conduct of parades, processions or public events, to restrict or prohibit traffic and/or parking in limited areas for periods of not more than 72 hours.

2. Such temporary and emergency regulations shall be enforced by the Police Department in the same manner as permanent regulations. Any person who shall operate or park a vehicle or tractor in violation of any such regulations, or who shall move, remove, destroy, injure or deface any sign or marking erected, posted or made to give notice of any such regulation, upon conviction thereof, shall be subject to the penalty set forth in the law or elsewhere in this Chapter for a violation of such nature, and, in case of a violation for which no specific penalty is set forth in the law or elsewhere in this Chapter, to a fine of not more than \$25 together with costs of prosecution.

#### **§15-105. Experimental Regulations.**

The Borough Council may, from time to time by resolution, designate places upon and along the highways in the Borough of Carroll Valley where, for a period of not more than 90 days, specific traffic and/or parking regulations, prohibitions and restrictions shall be in force and effect, and shall designate such locations by proper signs and markings. Such regulations, prohibitions and restrictions shall be effective as if they had been specified in this Chapter. No person shall operate or park a vehicle or tractor in violation of any such regulation, prohibition or restriction, and no person shall move, remove, destroy or deface any sign or marking erected, posted or made by authority of this Section. Any person who shall violate any provision of this Section, upon conviction thereof, shall be subject to the penalty set forth in the law or elsewhere in this Chapter for a violation of such nature, and in case of a violation for which no specific penalty is set forth in the law or elsewhere in this Chapter, to a fine of not more than \$25 together with costs of prosecution; provided, the purpose of this Section is to allow for the test and experimental determination of the feasibility and desirability of permanent changes in the ordinances of the Borough relative to traffic and parking.

#### **§15-106. Traffic on Streets Closed or Restricted for Construction, Maintenance or Special Events.**

1. The Borough Council shall have authority to close any street or specific part of a street to vehicular traffic and to place barriers or station police officers at each end of the closed portion, while construction or maintenance work is under way or a special event is being conducted on the closed portion. It shall be unlawful for any person to drive a vehicle upon any such closed portion.

2. The Borough Council shall have authority to establish a restricted traffic area upon any street where construction or maintenance work is under way and to station flagmen at each end of the restricted portion. It shall be unlawful for any person to drive a vehicle upon any such restricted traffic area at any time when the flagman is displaying a sign directing that vehicle to stop, or is signaling that vehicle, by a flag or other device, not to proceed.

3. Any person who violates any provision of this Section, upon conviction, shall

be sentenced to pay a fine of \$25 and costs.

**§15-107. Use of Streets by Processions and Assemblages.**

1. For the purpose of this Section, the words “assemblage” and “procession” shall have the following meanings:

*Assemblage* - a gathering of people without vehicles, which interferes with the movement of pedestrian or vehicular traffic on any street.

*Procession* - a group of individuals, vehicles, animals and/or objects moving along a street in a way that interferes with the normal movement of traffic. A procession shall not include a funeral caravan or military convoy.

2. It shall be unlawful for any person to hold or participate in any assemblage unless the person organizing or conducting the assemblage first obtains a permit from the Mayor, which shall be issued without fee. Application for the permit shall be made at least 1 week in advance of the day on which the assemblage is proposed to be held, but in any case where a state-designated highway is proposed to be used, application shall be made at least 3 weeks in advance of the proposed date. The permit shall state the place where and the date when the assemblage is to be held, the hour when the assemblage may convene and the hour by which it shall have been completely dispersed. It shall be unlawful for any person to hold or to participate in any assemblage unless the permit has been granted, or at any time or place other than that authorized by the permit.

3. It shall be unlawful for any person to hold or participate in any procession unless the person organizing or conducting the procession first obtains a permit from the Mayor, which shall be issued without fee. Application for the permit shall be made at least 2 weeks in advance of the day when the procession is proposed to be held, but in any case where a state-designated highway is proposed to be used, application shall be made at least 3 weeks in advance of the proposed date. The permit shall specify the date on which the procession is to be held, the route to be followed by the procession, the hour when and place where participants may commence to assemble and form before the procession is under way, the time when the procession may commence to move along its route, and the time by which the end of the procession shall have reached the end of the route of the procession and the procession shall have been disbanded. It shall be unlawful for any person to hold or to participate in any procession unless the permit shall have been granted, or under any conditions as to time or route or otherwise than those stated in the permit.

4. Any person who violates any provision of this Section, upon conviction, shall be sentenced to pay a fine of \$25 and costs.

**§15-108. Authority of Police Officers.**

The police officers of the Borough are hereby authorized to direct traffic on the highways of the Borough and at intersections thereof and to otherwise enforce the provisions of this Chapter.

**§15-109. Authorization for Use of Speed Timing Devices.**

1. The Borough Police Department is hereby authorized to use all speed timing devices for the determination of speed of a motor vehicle as are approved or will be approved by the Department of Transportation of the Commonwealth of Pennsylvania, in accordance with Title 75, Pa. C.S.A. §3368.

2. This Section authorizes the use of said devices upon all highways within the Borough, be they Borough, County or State highways, and does also hereby elect to exercise all powers granted to “local authorities” under the Vehicle Code of the Commonwealth of Pennsylvania, 75 Pa. C.S.A. §6101 *et seq.* (1977) as hereafter amended, supplemented, modified or reenacted by the General Assembly of Pennsylvania.

**Part 2****Traffic Regulations****§15-201. Maximum Speed Limits Established on Certain Streets.**

1. Maximum speed limits are established on portions of specified streets, as follows, and it shall be unlawful for any person to drive a vehicle, on any part of a street where a maximum speed limit applies, at a higher speed than the maximum prescribed for that part of the street:

2. Any person who violates any provision of this Section, upon conviction, shall be sentenced to pay a fine of \$35. Any person exceeding the maximum speed limit by more than 5 miles per hour shall pay an additional fine of \$2 per mile for each mile in excess of 5 miles per hour over the maximum speed limit.

#### **§15-202. Maximum Speed Limits Established on Certain Bridges and Elevated Structures.**

1. Maximum speed limits are established, as follows, on certain bridges and elevated structures, and it shall be unlawful for any person to drive a vehicle on any such bridge or elevated structure, at a higher speed than the maximum prescribed for that bridge or elevated structure:

2. Any provision who violates any provision of this Section, upon conviction, shall be sentenced to pay a fine of \$35. Any person exceeding the maximum speed limit by more than 5 miles per hour shall pay an additional fine of \$2 per mile for each mile in

excess of 5 miles per hour over the maximum speed limit.

**§15-203. Maximum Speed Limits Established for Certain Vehicles on Hazardous Grades.**

1. The following are declared to be hazardous grades, and, upon any such hazardous grade, no person shall drive a vehicle, having a gross weight in excess of that referred to for that grade, in the direction stated for that grade, at a speed in excess of that established in this Section for that grade, and, if so stated for a particular grade, the driver of every such vehicle shall stop the vehicle before proceeding downhill:

2. Any person who violates any provision of this Section, upon conviction, shall be sentenced to pay a fine of \$35. Any person exceeding the maximum speed limit by more than 5 miles per hour shall pay an additional fine of \$2 for each mile in excess of 5 miles per hour over the maximum speed limit.

**§15-204. Maximum Speed Limits Established in Parks.**

1. A speed limit of 15 miles per hour is established on all streets and roadways in the public parks maintained and operated by the Borough, except in the following locations, where the lower maximums, as specified, shall apply:

2. Any person who violates any provision of this Section, upon conviction, shall be sentenced to pay a fine of \$35. Any person exceeding the maximum speed limit by more than 5 miles per hour shall pay an additional fine of \$2 per mile for each mile in excess of 5 miles per hour over the maximum speed limit.

**§15-205. Traffic Signals at Certain Locations.**

1. At the following locations, traffic signals as indicated below shall be erected (or are ratified if previously erected), and traffic at those locations shall be directed by those signals:

2. Any driver of a vehicle who disobeys the directions of any traffic signal, upon conviction, shall be sentenced to pay a fine of \$25 and costs.

**§15-206. Intersections Where Turn Prohibited on Red Signal.**

1. The following are established as intersections where drivers of vehicles headed in the direction or directions indicated are prohibited from making a right turn (or a left turn from a one-way street into another one-way street) on a steady red signal:

**§15-207. One-Way Streets Established.**

1. The following are established as one-way streets, and it shall- be unlawful for any person to drive a vehicle on any one-way street other than in the direction established for traffic on that street:

**§15-208. Turning at Certain Intersections Prohibited or Restricted.**

1. It shall be unlawful for the driver of any vehicle, of the type indicated, traveling upon the first-named street at any of the following intersections, in the direction or directions indicated in each case, to make a left turn and/or a right turn into the second-named street, as indicated, at any time when such a turn is prohibited by this Section:

**§15-209. Right Turns Only Permitted at Certain intersections.**

1. It shall be unlawful for the driver of any vehicle, traveling upon the first-named street at any of the following intersections, in the direction or directions indicated in each case, to make other than a right turn, at any time stated, both left turns and straight-across traffic being prohibited:

### **§15-210. U-Turns Prohibited at Certain Locations.**

1. It shall be unlawful for the driver of any vehicle, traveling upon any of the following portions of streets, in the direction or directions indicated for that street, to make a U-turn:

### **§15-211. No Passing Zones Established.**

1. The following are established as no passing zones, and it shall be unlawful for the driver of any vehicle to overtake or pass another vehicle or to drive on the left side of the roadway in any no passing zone:

### **§15-212. Through Highways Established.**

1. The following highways are established as through highways, thus authorizing stop or yield signs to be erected facing traffic approaching every intersection with the through highway except for those intersections with traffic signals, or with exceptions or modifications as indicated below. Every driver of a vehicle approaching a stop or yield sign authorized by this Section shall stop the vehicle or yield right-of-way as required by §3323(b) or §3323(c) of the Vehicle Code, as the case may be, and shall not proceed into or across the through highway until he has followed all applicable requirements of that Section of the law:

## Part 4

### General Parking Regulations

#### **§15-401. Vehicles to Be Parked Within Marked Spaces.**

Wherever a space is marked off on any street for the parking of an individual vehicle, every vehicle parked there shall be parked wholly within the lines bounding that space, and it shall be a violation of this Part for any person to park a vehicle or allow it to remain parked otherwise.

#### **§15-403. Parking on Private Property.**

No person shall park or leave unattended a vehicle on private property without the consent of the owner or other person in control or possession of the property except in case of emergency or disablement of the vehicle, in which case the operator shall arrange for the removal of the vehicle as soon as possible.

2. The provisions of this Section shall not apply to private parking lots unless such lots are posted to notify the public of any parking restrictions and the operator of the vehicle violates such posted restrictions. For the purposes of this section “private parking lot” means a parking lot open to the public or used for parking without charge; or a parking lot used for parking with charge.

#### **§15-409. On-Street Parking.**

1. *On-street Parking.* No person shall stop, park or stand any vehicle, whether attended or unattended, upon the roadway when it is practicable to stop, park or stand the vehicle off the roadway. In the event it is necessary to stop, park or stand the vehicle on the roadway or any part of the roadway, an unobstructed width of the highway opposite the vehicle shall be left for the free passage of other vehicles, and the vehicle shall be visible from a distance of 500 feet in each direction upon the highway. When a vehicle stops, parks or stands on Borough streets (roads, trails) the vehicle is to be positioned with the right side (passenger side) of the vehicle along the right side of the street, and the vehicle shall be parked in a manner which does not violate subsections .2 and .3 below and §15-602 of this Chapter.

2. *Parking Prohibited at Intersections.* There shall be no parking at any time within 30 feet of any intersection or within 30 feet of any warning sign or other sign or device used to control traffic.

3. *Standing or Parking Prohibited at End of No Outlet Roads.* No person shall park or stand any vehicle, whether attended or unattended, upon the roadway of a turn-around circle, at the ends of roads, streets or trails, or within 50 feet of a turn-around circle. "Stand" shall mean to halt a vehicle, whether occupied or not, except momentarily for the purpose of and while actually engaged in receiving or discharging passengers, or to make immediate, emergency repairs to the vehicle.

#### **§15-410. Penalties.**

Any person who violates any provision of this part, upon conviction, shall be sentenced to pay a fine of not less than \$40 nor more than \$50 plus costs. Provided: It shall be the duty of the police officers and of the parking enforcement personnel of the Borough to report to the Chief of Police all violations of any provision of this Chapter or of Title 75, Pennsylvania Vehicle Code, regarding parking prohibitions, indicating in each case: the nature of the violation; the license number of the vehicle; the location of the violation; and any other facts that might be necessary to understand the circumstances of the violation. The police officer or other person making the report shall also attach to or place upon every such vehicle a notice stating that the vehicle was parked in violation of this Part. The notice shall contain instructions to the owner or driver of the vehicle that if he or she mails or delivers to the Carroll Valley Borough Police Department the sum of \$50 for violation regarding handicap parking or \$25 for all other violations within 5 days after the stated time of the notice, that act will save the violator from prosecution and from payment of the fine and costs prescribed in the first sentence of this Section.

**§15-411. Commercial Motor Vehicle Parking Regulations.**

1. *Short Title.* This Section shall be known as the “Borough of Carroll Valley Commercial Motor Vehicle Parking Regulations Ordinance” and may be cited as such.

2. *Declaration of Purpose.* The purpose of this Section is to preserve the integrity of the Borough road network and to protect the health, safety and general welfare of the citizens of Carroll Valley Borough, motorists, and pedestrians by regulating the parking of commercial vehicles within the residential areas of the Borough.

3. *Definitions.* The definitions of terms used in this Part shall be as set forth in Title 75, Chapters 1 and 16, of the Pennsylvania Consolidated Statutes known as the Pennsylvania Vehicle Code unless otherwise defined.

4. *Parking of Commercial Motor Vehicles and Motor Carrier Vehicles Prohibited.*

A. No person shall park or allow the parking of a commercial motor vehicle or a motor carrier vehicle as defined in this Part, except truck tractors, in areas zoned Residential or Woodland Conservation except when such vehicles are performing a service and only for the time required to complete such service, nor can such vehicles be used for storage purposes in areas zoned Residential or Woodland Conservation.

B. Nothing in this section shall be construed to exempt any person from any other section of this Chapter.

5. *Responsibility.* The owner of the commercial vehicle or motor carrier vehicle stored or parked in areas zoned Residential or Woodland conservation, as well as the owner of the property upon which the vehicle is parked, shall be responsible for violation of this Section. The person to whom the vehicle is registered as determined from the registration plate displayed on such vehicle shall be presumed in evidence to be the owner of such vehicle. For purposes of determining the ownership of the property, it shall be presumed that the person whose name appears on the most recent tax assessment roll of the Borough of Carroll Valley to be the owner of the property.

6. *Penalties.* Any person, firm or corporation who shall violate any provision of this Part, upon conviction thereof, shall be sentenced to pay a fine of not less than \$25 nor more than \$600 plus costs and any restitution ordered and, in default of payment thereof, to imprisonment for a term not to exceed 30 days.

## Part 5

### Removal and Impoundment of Illegally Parked Vehicles

#### §15-501. Applicability and Scope.

This Part is enacted under authority of §6109(a-22) of the Vehicle Code, and gives authority to the Borough Police to remove and impound those vehicles which are parked in a tow away zone or in violation of parking regulations of this Chapter. Vehicles which have been parked or abandoned in violation of the Vehicle Code or which are parked in such a manner as to interfere with traffic or pose a hazard to others, may be towed under the provisions of the Pennsylvania Vehicle Code.

#### §15-502. Authority to Remove and Impound.

The Borough Police shall have authority to remove and impound, or to order the removal and impounding, of any vehicle parked illegally, provided that the circumstances of its parking were within the conditions stated in §15-501 of this Chapter. Provided: no such vehicle shall be removed or impounded except in strict adherence to the provisions of this Part, or the provisions of the Pennsylvania Vehicle Code.

#### §15-503. Tow Away Zones Designated.

The following designated streets and/or parking lots are hereby established as tow-away zones. Signs shall be posted to place the public on notice that their vehicles may be towed for violation of the Borough parking regulations:

#### §15-504. Designation of Approved Storage Garages, Bonding, Towing and Storage.

Vehicles may be impounded at either an “approved storage garage” or in the Borough impoundment area. Every approved storage garage shall submit evidence to Borough Council that it is bonded or has acquired liability insurance in an amount satisfactory to Borough Council as sufficient to indemnify owners of impounded vehicles against loss or damage to those vehicles while in the custody of the garage keeper for the purpose of towing or storage.

**§15-505. Payment of Towing and Storage Charges.**

The payment of towing and storage charges shall not relieve the owner or driver of any vehicle from liability for any fine or penalty for the violation of the provision of this Part for which the vehicle was removed or impounded.

**§15-506. Reclamation Costs.**

The owner of the vehicle impounded shall be liable for the towing charge, administrative impound fee and storage charge in an amount as established from time to time by resolution by Borough Council.

**§15-507. Records of Vehicles Removed and Impounded.**

The Chief of Police shall cause a record to be kept of all vehicles impounded under this Part and shall be able at all reasonable times to furnish the owners or the agents of the owners of those vehicles with information as to the status of the vehicles.

**§15-508. Restrictions Upon Removal of Vehicles.**

No vehicle shall be removed under authority of this part, if at the time of intended removal, the owner or person in charge of the vehicle is present and expresses a willingness and intention to remove the vehicle immediately and is physically able to do so.

**§15-509. Penalty for Violation.**

Any person who shall violate any provision of this Part, upon conviction thereof, be shall sentenced to pay a fine of not less than \$50 together with all costs of disposing of the vehicle under provisions of the Vehicle Code, 75 P.S. §7301 *et seq.*, (1977), as hereafter amended, supplemented, modified or reenacted by the General Assembly of Pennsylvania.

**§15-510. Reports and Disposition of Unclaimed Vehicles.**

If after a period of 15 days the vehicle in storage remains unclaimed the vehicle may be transferred to a licensed salvor who will then be responsible for filing the proper reports and disposing of the vehicle in accordance with the provisions of Chapter 73 of the Pennsylvania Motor Vehicle Code, 75 Pa.C.S.A. §7301 *et seq.*, as amended.

**§15-511. Notification of Removal and Impounding.**

1. Within 24 hours from the time of removal of any vehicle under authority granted by this part, notice of the fact that the vehicle was removed shall be sent by the Police Department to the owner of record of the vehicle. This notice shall designate the

place from which the vehicle was removed, the reason for removal and impounding, and the location of the vehicle.

2. When the owner or person in control of the vehicle is present the officer initiating the removal/impounding of the vehicle shall inform that person of the requirements of this Section and this notice shall fulfill the requirements set forth.

**Part 6****Snow and Ice Emergency****§15-601. Declaration of Snow and Ice Emergency.**

In order to facilitate the movement of traffic and to combat the hazards of snow and ice on the snow emergency routes named in §15-603 of this Part, the Council President or his/her designee, may declare a snow and ice emergency (designated in this Part as a “snow emergency”). Information on the existence of a snow emergency shall be given by the Borough through radio, newspaper or other available media, and information on the termination of the emergency may be given by use of the same media.

**§15-602. Parking Prohibited, Driving Motor Vehicles Restricted on Snow Emergency Routes During Emergency.**

After any snow emergency is declared, it shall be unlawful, at any time during the continuance of the emergency, for any person:

A. To park a motor vehicle or to allow that vehicle to remain parked on any Borough road or in any Borough right-of-way in such a manner as to impede or obstruct the snow and ice removal efforts of the Borough of Carroll Valley or to create a hazardous condition.

B. To drive any motor vehicle on the snow emergency route as designated in §603 of this Part, unless that vehicle is equipped with snow tires or chains.

**§15-603. Snow Emergency Routes Designated.**

The following are designated as snow emergency routes:

A. All Borough roads so designated on the Borough of Carroll Valley official Street Map, and as amended from time to time.

**§15-604. Penalty for Violation.**

1. If, at any time during a period of snow emergency declared under §15-601 of this Part, a person shall park a motor vehicle or allow a motor vehicle to remain parked anywhere on the road or in the right-of-way in such a manner as to impede or obstruct the snow and ice removal operations of the Borough of Carroll Valley or creates a hazardous condition, that person shall be guilty of a violation of this Part, and upon conviction, shall be sentenced to pay a fine of \$50 and costs. Provided: It shall be the duty of the police officers and of the parking enforcement personnel of the Borough to report to the Chief of Police all violations of this section indicating in each case: the nature of the violation; the license number of the vehicle; the location of the violation; and any other facts that might be necessary to understand the circumstances of the violation. The police officer or other person making the report shall also attach to or place upon every such vehicle a notice stating that the vehicle was parked in violation

of this Part. The notice shall contain instructions to the owner or driver of the vehicle that if he or she mails or delivers to the Carroll Valley Borough Police Department the sum of \$40 with 5 days after the stated time of the notice, that act will save the violator from prosecution and from payment of the fine and costs prescribed in the first sentence of this Section.

2. If, at any time during a period of snow emergency declared under §15-601 of this Part, a person shall drive a motor vehicle upon a snow emergency route, without having that vehicle equipped with snow tires or chains, that person shall be guilty of a violation of this Part, and, upon conviction, shall be sentenced to pay a fine of \$25 and costs.

## Part 7

### Regulation of Pedalcycles and Non-motorized Vehicles

#### **§15-701. Riding and Parking of Pedalcycles on Sidewalks Along Certain Streets Prohibited.**

1. It shall be unlawful for any person to ride or to park a pedalcycle on the sidewalk along the following portions of the streets in the Borough:

2. Any person who violates any provision of this Section, upon conviction, shall be sentenced to pay a fine of \$5 and costs.

#### **§15-702. Restrictions on Use of Pushcarts.**

1. The word “pushcart,” as used in this Section, shall mean a vehicle, including a pedalcycle, propelled solely by human power, and used or intended for use for the display, transport, exhibit or sale of goods, wares or merchandise.

2. It shall be unlawful for any person to propel a pushcart upon any sidewalk in any business district except as necessary to move the pushcart to a location from which it is to be loaded or unloaded or from which goods, wares or merchandise are to be sold or dispensed under permit from Borough Council as provided in subsection .3 hereof.

3. It shall be unlawful for any person to park a pushcart upon any sidewalk except for the purpose of selling or dispensing from that pushcart goods, wares or merchandise to passersby under permit from Borough Council. Every such permit shall be issued to the person making application for the permit, upon payment of a fee, which shall be for the use of the Borough, set by the Borough Council pursuant to a Resolution. The permit shall be granted to the applicant, upon payment of the fee, and upon his signing an agreement with Borough Council that he shall be bound by the conditions imposed by Borough Council and made a part of the permit, dealing with the following matters:

A. Restricting or limiting the parking of the pushcart to one or more stated locations upon the sidewalk and to stated days and hours at each location.

B. Stating requirements to be adhered to in connection with the disposal of garbage and refuse resulting from the operations carried on.

C. Requiring that there be no violation of any law, Chapter or regulation pertaining to health, sanitation and the handling of food or drink.

4. Any person who violates any provision of this Section, or any condition of any permit granted under this Section, shall be guilty of a summary offense, and, upon conviction, shall be sentenced to pay a fine of \$25 and costs.

**§15-703. Skates, Skateboards, Coasters, Sleds and Other Toy Vehicles.**

1. It shall be unlawful for any person to ride on a sled upon any sidewalk in the Borough, or upon any roadway unless that roadway is on a portion of a street blocked off for sledding by authority of §15-105 of Part 1 or §15-216 of Part 2 of this Chapter. Provided: nothing in this subsection shall prevent a pedestrian from pulling a sled, with or without a rider, upon a sidewalk.

2. It shall be unlawful for any person to engage in roller-skating, skateboarding or to ride upon or propel any coaster or other toy vehicle upon:

A. Any street except in order to cross the roadway.

B. Any sidewalk located in a business district, except that nothing in this paragraph shall prevent a pedestrian from pulling a coaster or other toy vehicle, with or without a rider, upon a sidewalk.

3. Any person who violates any provision of this Section, upon conviction, shall be sentenced to pay a fine of \$5 and costs.
