### **Municipal Building Project**

- Mr. Hazlett outlined the Memorandum dated January 24, 2017 entitles Furniture, Fixtures and Equipment:

  - Verbiage regarding the financial assistance is required as a condition of the RACP Grant Award. It was suggested to include Janis Ashman as she was Council President for most of the building project. Mr. Hazlett will make the necessary corrections.
  - Size is suggested to be 16" x 20"
