MINUTES

Mr. Mathews asked if any Member had an addition to the agenda. Hearing none; Mr. Mathews continued with the agenda as it was posted.

CONSIDERATION OF THE MINUTES OF THE JANUARY 11, 2022 REGULAR MEETING

Mr. Lillard asked that the record reflect that he participated via phone until his arrival in person at 7:39pm. Following brief discussion:

*** J. Schubring moved; D. Lillard seconded, that the minutes of the January 11, 2022 Regular Meeting be approved as corrected. Motion passed unanimously.

Public Hearing

The Advertised Public Hearing was opened at 7:10 pm by Council President, Richard Mathews; he introduced Borough Consultant, Robert Thaeler, of the Adams County Planning Office who outlined the proposed Ordinance #1-2022 and gave a brief overview of the Process for developing the Ordinance and guidelines for the Hearing. The following individuals addressed Members at this time:

- Ambrose Heinz, Stevens &Lee, Attorney for Illuma, Inc. stating the following concerns:
 - o Re-Zoning from R2 (medium density residential) to R1 (low density residential)
 - No Accommodations for Cluster Housing
 - No Accommodations for Townhouses
 - o Not Consistent with the approved Joint Comprehensive Plan of 4-units per acre
- Sean Jones, 15 East Wind Trail, Carroll Valley in support of the low density designation stating that the infrastructure is not built to handle the increased traffic and population.
- Jale Dalton, 8 Gingell Road, Carroll Valley requesting properties addressed as 2-B Gingell Road remain in the Commercial Zoning District stating that in the proposed document these properties are now labeled as R2 (medium density residential). Mr. Hazlett spoke to this issue stating that it was an oversite that can be corrected.
- Written Correspondence from those not able to attend in-person was entered into the record by Mr. Hazlett:
 - o Lexy Dalton-Welty requesting the zoning correction on Gingell Road

o Mr. and Mrs. John Laramie requesting additional review of the short-term rental (air b and b) regulations

Mr. Mathews requested additional comment; hearing no one:

- Sean Jones, 15 East Wind Trail, Carroll Valley regarding the following issues:
 - o Request for Speed Limit Sign on East Wind Trail
 - o Parking of Liberty Mountain employees and guests along East Wind and Plainview Trails
 - Chief Hileman stated that tickets have been issued to those parking in the "No Parking Zone" along East Wind Trail; however, there are no regulations for Plainview Trail at this time.
 - Concern that Liberty Mountain is not maintaining security at their entrance gate.
 - Potholes on East Wind Trail
 - Mr. Hazlett confirmed that East Wind Trail is scheduled for repairs in the Spring.
 - Mr. Hazlett will evaluate the area for more immediate remediation.

Ordinance #1-2022: Chapter 27 - Zoning. In light of the issues shared during the Public Hearing and after brief discussion that included the general consent of Members to correct the Commercial Zoning oversight along Gingell Trail:

Carr seconded that Council approve the advertising of a second (2nd) Public Hearing to be held on Tuesday, March 15, 2022 at 7:00pm to take comments regarding Ordinance #1-2022:Chapter 27 – Zoning; with the intent to adopt at the April 12, 2022 meeting of Council. Motion passed unanimously.

The reward that was offered for information led to the identification of a 17-year-old area youth who has been arrested on felony aggravated animal cruelty charges. The person responsible for the identification donated their reward to local animal abuse shelters.

COMMITTEE REPORTS

Planning Commission.

Mr. Wight, Planning Commission Chair provided a written report outlining the discussion from the February 7, 2022 meeting. Members accepted the report without comment.

ADMINISTRATIVE BUSINESS – BOROUGH MANAGER

Treasurer's Report for December 2021.

Following brief discussion:

***B. Carr moved, J. Schubring seconded, that Council accept the January 2022 Treasurer's Report as presented. Motion passed unanimously.

2022 Curbside Collection, Transportation and Processing of Municipal Solid Waste and Recyclables Contract.

Members reviewed Mr. Hazlett's memorandum of February 11, 2022 outlining the Bid Tabulation. Also provided was the 2022 Trash Contract Bid Analysis prepared by Mr. Mathews. Following brief discussion:

***R. Verderaime moved; D. Lillard seconded that Members authorize that the 2022 Contract for Curbside Collection, Transportation and Processing of Municipal Solid Waste and Recyclables be awarded as Option #1 to Parks Garbage for the 3-year term plus an optional 1-year extension at the following prices:

MSW Collection and Disposal (Including large item, covered device recycling drop-off events, Bi-Weekly recycling) - Annual Cost	\$303.00
Standard per-bag service (12 tags)	\$60.00
Additional bags	\$5.00
Wheeled Toter - Annual Cost	\$24.00

Motion passed unanimously.

Adams County Historical Society Request.

Following brief discussion:

***J. Schubring moved that Members consider granting the requested donation of \$20,630 to the Adams County Historical Society. The Motion died for lack of a second.

UNFINISHED BUSINESS

Grant Funding Updates.

Members reviewed the written report supplied by Marissa Price of GMS Funding Solutions outlining the various grants being managed by her agency. The report was accepted by consensus without discussion.

Property Maintenance.

Mr. Mathews shared the information from the Planning Commission Meeting where the issue of Health and Safety as they relate to blight in the form of fire damaged, burned-out, collapsed or similar dangerous structures. Mr. Hazlett again offered to pilot a tour of the Borough for Members to see and identify problem areas and subsequent deficiencies in the current ordinances. Mr. Mathews again recommended that other members schedule a ride-along with Mr. Hazlett.

High-Speed Broadband Update.

Mr. Hazlett confirmed that the project is in the queue for construction by Comcast for August 2022 construction date at no cost to the municipalities.

Cortner Pavilion Project.

Mr. Hazlett reported that work continues and remains on target; monthly updates will continue to be provided.

Conveyance of Sewer and Water Authority Update.

Next Sewer and Water Authority meeting is scheduled for Monday, February 28, 2022 at 7:00pm; this topic will be discussed.
