#### Ordinance # 1-2010: H-Section Speed Ordinance

\*\*\* K. Lundberg moved; F. Buhrman seconded, that Council adopt the proposed Ordinance # 1-2010 as presented. Motion carried unanimously by roll call.

# Resolution #07-2010: Designation of Agent – Snow Emergency 2010

\*\*\*N. Abrams moved; T. Lytle seconded, that Council adopt Resolution #07-2010 designating David A. Hazlett the Agent Authorized to execute all required forms and documents for the purpose of obtaining financial assistance under the Robert T. Stafford Disaster Relief and Emergency Assistance Act. Motion carried unanimously.

#### Resolution #08-2010: Acceptance of Deed of Easement

**Award of the 2010 Joint Materials Bids.** Mr. Hazlett asked that the Members review the bid tabulation provided and award the bids. The following actions were taken:

- \*\*\*T. Lytle moved; D. Patton seconded that the Contract for Aggregate be awarded to Valley Quarries as the only responsible bidder. Motion carried unanimously.
- \*\*\*N. Abrams moved; K. Lundberg seconded that the Contract for various Road Oils be awarded to Hammaker East, LTD as the lowest responsible bidder. Motion carried unanimously.
- \*\*\*T. Lytle moved; F. Buhrman seconded that the Contract for Bituminous Supplies be awarded to Valley Quarries as the lowest responsible bidder. Motion carried unanimously.
- \*\*\*K. Lundberg moved; F. Buhrman seconded that the Contract for Line Painting be awarded to Alpha Space Control Company as the only responsible bidder. Motion carried unanimously. \*\*\*F. Buhrman moved; D. Patton seconded that the Contract for Seal Coating be awarded to Hammaker East, LLC as the lowest responsible bidder. Motion carried unanimously.

Mr. Hazlett explained that there were no bids received for Fuel and asked that the members approve the re-bidding of these items:

\*\*\*F. Buhrman moved, T. Lytle seconded, that the Gasoline, Diesel Fuel and Home Heating Oil requirements of the Municipality be re-advertised as required by Borough Code. Motion carried unanimously.
