April 16, 2011 Flooding. Mr. Hazlett provided Members with a brief description of the damages and a cost estimate for repairs. The total has been submitted to Adams County EMA in hopes that if the incident is declared an emergency we will be eligible for federal and state aid for the more than \$150,000 in damages.

Adams County Tax Collection Committee. Mr. Hazlett shared information regarding the May 4, 2011 meeting of ACTCC. After lengthy discussion, Members by consensus agreed to have the voting delegates cast a "No" vote to option #3 and cast a "Yes" vote to option #1 or abstain from the vote.

Civil War – 150th Anniversary Program. Mr. Hazlett and Mayor Harris provided a brief follow-up on the activities. The event was well attended and enjoyed by all. The committee will remain active as they begin planning next year's event.
