ORDINANCES AND RESOLUTIONS

Ordinance #3-2011: Tax Levy Ordinance. Mr. Hazlett asked that the vote be tabled until after discussion of the budget. Members agreed by consensus.

Planning Commission. Mr. Ed Kaplan stated that Borough Staff has the final revisions for the Comprehensive Plan and that the document should be ready for Council review in January.

Mr. Kaplan outlined a proposed ordinance that would amend Chapter 2 of the Code of Ordinances to permit the limited keeping of domesticated chickens on residentially zoned property. Resolution #08-2011: 2012 Fee Schedule.

***W. Reinke moved, N. Abrams seconded that Council adopt Resolution #8-2011: 2012 Fee Schedule as presented. Motion carried unanimously. **2012 Holiday Schedule.** Schedule was accepted by consensus.

Adams County Tax Claim Bureau – Repository Sale Bids. Following brief discussion: ***F. Buhrman moved, W. Reinke seconded that Council accept Offer #2 for all lots as it was the highest on each lot. Motion carried unanimously.

Borough of Carroll Valley 457 Deferred Compensation Plan Amendment. Following brief discussion:

Buhrman seconded that Council approve the Amendment for Pension Protection Act ("PPA"), Heroes Earning Assistance and Relief Tax Act of 2008 ("HEART"); Worker, Retiree and Employer Recovery Act of 2008 ("WRERA") for Governmental 457(b) Plan #612489 as presented. Motion carried unanimously.

York Water Company's PUC Expansion verification Request. Mr. Hazlett explained that the York Water Company is in negotiations to purchase Section A Water Corporation and that the Public Utility Commission (PUC) has requested that the Borough complete a questionnaire. Following its review; Members agreed by consensus to have Borough Staff complete the questionnaire and submit same to PUC.
