UNFINISHED BUSINESS

Mr. Hazlett reported that an RFP for financing of the Building Project would be developed and sent to interested parties.

Mr. Baker, zoning officer, will begin his annual check of the Borough for proper placement of house/address signs. Mr. Abrams commended this initiative as a past Captain of the Ambulance Service; he shared experiences where public safety was jeopardized by the failure of homeowners to properly mark their houses.

NEW BUSINESS

Mr. Hazlett asked for Council direction regarding a growing issue that involves property maintenance in Borough Ordinance §25-201 and §25-202. The zoning office has received several requests to investigate violations of this ordinance that results in the zoning officer determining the lot accused of violating the ordinance is an unimproved or vacant lot. Mr. Hazlett questioned as to the intent of the ordinance; was the partial clearing and ongoing maintenance of a vacant lot the intended purpose of this Ordinance? After brief consideration; Members asked that the issue be reviewed by the Planning Commission.

• Marge Cook, 1 Side Track Trail, CV: Asked that the Borough review the line of sight from Lion Trail onto Country Club Trail. She states that the intersection is very dangerous. Mr. Hazlett agreed to ask that Chief Hileman work with the Road Master, Terry Weikert to evaluate the situation and report any findings.
