**Finance Committee:** Mr. Buhrman reported that the committee reviewed the 2014 Proposed Budget. The Budget as presented has a \$1500 surplus of expected revenue over anticipated expenses. There has been no allowance for the Full-Time Officer although Mr. Hazlett reported that that approximately an additional \$40,000 would be needed for salary and benefits over the Part-Time Officer Wages budgeted.

**Parks, Recreation and Environmental Advisory Committee:** Mrs. Lytle provided updates for the following:

# ADMINISTRATIVE BUSINESS – BOROUGH MANAGER

Treasurer's Report for September 2013. Following brief discussion:

\*\*\* D. Patton moved, F. Buhrman seconded, that Council accept the September 2013 Treasurer's Report as presented. Motion passed unanimously.

**Solid Waste Contract.** Mr. Hazlett outlined the Bid Tabulation prepared by the County for the 3-year Contract for Solid Waste Hauling for the Borough. Parks Garbage Service, Inc. has submitted the lowest responsible bid.

Following brief discussion:

\*\*\*N. Abrams moved; F. Buhrman seconded that Council award the Contract to Parks Garbage Service, Inc with the lowest responsible bid. Motion carried unanimously.

**2014 MMO.** Mr. Hazlett reviewed the memorandum outlining the Minimum Municipal Obligation for the 2014 Employee Pension Plan.

**2014 Liquid Fuels Allocation.** Mr. Hazlett reviewed the estimated allocation of Liquid Fuels funding the Borough could expect in 2014 for road maintenance and improvements.

**Ordinance #2-2013 – Zoning Change Regarding Cluster Developments.** Mr. Hazlett explained that due to an unexpected delay, the Adams County Planning Commission Comments were not given the allotted time for submittal as outlined in the PA Planning Code. Therefore, the Members were asked to permit Borough Staff to advertise the Public Hearing regarding Ordinance # 2-2013 for November 12, 2013 during the Regular meeting of Council and Advertise that the Council intends to consider Adoption of Ordinance # 2-2013 at the November 12, 2013 Regular Meeting: \*\*\*K. Lundberg moved; T. Lytle seconded that Ordinance #2-2013 – Zoning Change Regarding Cluster Developments be advertised for the Council's Intent to Adopt and the Public Hearing regarding Ordinance # 2-2013 for November 12, 2013 at the Regular Meeting of Council. Motion passed unanimously.
