Planning Commission:

Mr. Ed Kaplan, Commission Chairman reported on the following:

- Ordinances:
 - Cluster Housing under review by members and the Borough Solicitor has been asked to attend the April meeting in order to offer his professional opinion and answer outstanding questions.
 - o Domestic Chickens following discussion, the Commission recommended that the Council stand by its 2012 decision and not revisit the issue.
- Brief overview of the South West Adams County Joint Comprehensive Plan and shared that the County representatives will be presenting more details in the near future.

2014 Capital Purchase. Mr. Hazlett reviewed the memorandum and supporting documents regarding the purchase of a 2015 Mack GU432 model chassis with dump body, plow and spreader. He explained that this vehicle is identified in the approved 2014 Capital Fund Budget and requests permission to initiate the purchase from State Contract. Following brief discussion:

T. Lytle moved; N. Abrams seconded that Council approve the Capital Expenditure of \$138,069.84 for a 2015 Mack GU432 chassis with dump body, plow and spreader as outlined. Motion passed unanimously.
