Ordinance #2-2014 – Zoning Change Regarding Cluster Developments. Following brief explanation of procedure:

K. Lundberg moved; J. VanVolkenburgh seconded a motion to approve Ordinance #2-2014 amending part 6, section F of the Carroll Valley Borough Zoning Ordinance regarding regulations for cluster, townhouse and multi-family dwelling development. Upon a roll-call vote Mr. Lundberg and Mr. VanVolkenburgh voted yes and Mr. Abrams, Mr. Fitzsimmons, Ms. Ashman and Mr. Patton voted no; with a 4-2 vote, the ordinance failed to pass.

Upon a Motion by T. Fitzsimmons and seconded by J. Ashman, Council Members agreed to recess the meeting for 10 minutes. Motion passed unanimously.

#### ADMINISTRATIVE BUSINESS – BOROUGH MANAGER

Treasurer's Report for April 2014. Following brief discussion:

\*\*\*D. Patton moved, K. Lundberg seconded, that Council accept the April 2014 Treasurer's Report as presented. Motion passed unanimously.

**FY2013 Audit.** Mr. Hazlett reviewed the document stating that there were no findings and asked that Members take action to advertise the audit as required by State Borough Code.

\*\*\* K. Lundberg moved; N. Abrams seconded that Council authorize Borough Staff advertise the FY2013 Audit as required. Motion passed unanimously.

**FY2012 Liquid Fuels Audit.** Mr. Hazlett reviewed the document stating that there were no findings and asked that Members accept the document as presented. Consensus to accept the FY2012 Liquid Fuels Audit was met.

Adams Electric Street Light Replacement. Mr. Hazlett explained that Adams Electric has notified the Borough that they will begin replacing the Mercury Vapor Street Lights with LED ones in the coming months. The Borough was asked to evaluate its need for all of the Street Lights and consider eliminating any that are deemed unnecessary. During this discussion it was suggested that written guidelines be established to determine the criteria for Street Light placement and installation. This issue was referred to the Public Safety Committee.

#### **UNFINISHED BUSINESS**

**Municipal Building.** Mayor Harris provided a brief update requested that Members consider the hiring of an architect to move the project forward:

\*\*\*K. Lundberg moved, D. Patton seconded that the Borough Council accept the proposal of Murray Associates to provide the architectural services relative to the design and construction of the new Carroll Valley Borough Municipal Building, and to direct the Council President to execute the contract following satisfactory review of references and final legal review.

**Liberty Mountain Project: Developer's Agreement.** Mr. Wiser and Mr. Hazlett shared that work has continued on the Developer's Agreement and asked that Members approve the execution of the Agreement with the following four (4) documents: 1) Developers' Agreement; 2) Security Agreement; 3) Escrow Agreement and 4) Stormwater Operation and Maintenance Agreement.

\*\*\*K. Lundberg moved; J. Ashman seconded that Mr. Sam Wiser, Borough Solicitor execute the Developers' Agreement for the Liberty Mountain Project as prescribed. Motion passed unanimously.

#### **NEW BUSINESS**

Resolution #6-2014 – Addressing the Exchange of Lots. Mr. Hazlett explained that this resolution was requested by the courts in order to complete the 2013 agreement that Council made with Mr. Beckett regarding the exchange of two borough properties in trade for properties owned by Mr. Beckett. Due to the terms of the Borough's current Deeds for the properties in question; it is necessary to have Borough Staff authorized to sign closing documents and Mr. VanVolkenburgh to sign the new Deeds. Following brief discussion:

\*\*\*D. Patton moved; N. Abrams seconded that Resolution #6-2014 addressing the exchange of lots be accepted authorizing Borough Staff and Mr. VanVolkenburgh to sign the appropriate paperwork. Motion passed unanimously.

Borough Staff was asked to post the Chapter 94 Report and provide it electronically to Council Members.
