- Committee Vacancy left by the resignation of Mr. Abrams was discussed. Mr. Kaplan reported that two (2) applications were submitted and after careful consideration; Commission Members unanimously recommend that Council appoint Robert Tyler Pyles to the Planning Commission.

Southwest Regional Comprehensive Plan Public Hearing. Ms. Marthers and Mayor Harris explained that the next step in the approval process requires a Public Hearing and the County Coordinator for the Project has invited Carroll Valley to participate in a Joint Public Hearing on Thursday, March 26, 2015 to be held at the Fairfield Borough Building at 6:00pm. The request is for the Borough to send a Quorum of Attendees thereby fulfilling the Public Comment requirement for each municipality included in the Plan; and further, to request the County Planning Office provide the required Review of the Document. Following lengthy discussion:

***N. Abrams moved, T. Lytle seconded that the Borough participate in the Public Hearing and

Request the County Review and outlined by the County Coordinator. Motion passed with Ms. Ashman, Mr. Fitzsimmons and Mr. Patton voting no.
