## ADMINISTRATIVE BUSINESS – BOROUGH MANAGER

**Treasurer's Report for January 2016.** New Council Members asked for additional explanation regarding the various accounts and funds noted on the financial reports for clarification and better understanding of the information being reviewed. Borough Staff provided answers and following brief discussion:

\*\*\* D. Patton moved, S. Skoczen seconded, that Council accept the January 2016 Treasurer's Report as presented. Motion passed unanimously.

**Blizzard of 2016.** Mr. Hazlett commended the Borough Road Crew for an outstanding job in having the Borough roads open and maintained so well during the 3-day event that dropped over 2 feet of snow followed by gusting winds. Council Members agreed that the Borough roads maintenance efforts were exceptional throughout the storm.

**Snow Assistance Cost Reimbursement.** Mr. Hazlett explained that because Governor Wolf declared a state of emergency; the Borough may be eligible for reimbursement for costs associated with the snow clean-up. Borough Staff is tallying the most expensive 48-hour period of the storm and preparing the required FEMA/PEMA forms. Estimated eligible reimbursement is \$10,000 or more provided the county qualifies for the assistance.

**Rt 116 Road Safety Audit.** Mr. Hazlett shared that he attended a meeting of Hamiltonban Township Supervisors at their request where the issue of safety along State Rt 116 was discussed and it is the desire of that group to work with the Adams County Transit Authority to have a safety audit performed. Members agreed by consensus to have Mr. Hazlett continue to represent the Borough interests and suggested that the audit include the intersection of Rts 116 and 16 at Zora.

**New Website.** Mr. Hazlett announce the launch of the new Borough Website; the first overhaul in 5 years or so. New features include direct, real-time updates from social media (specifically Facebook) can be seen on the home-page and links to on-line permit applications. Although not 100% operational, the site is expected to be much easier for Staff to update and the Public to access.

#### **UNFINISHED BUSINESS**

**T-N-R Program.** Mrs. Skoczen provided the following information and updates:

- 40 cats have been served by the Program
- Funding provided by the Borough was supplemented through private donations and a Senior High School Project fundraiser
- Next Planned Trapping:
  - o Weekend of February 12<sup>th</sup> through the 14<sup>th</sup>
  - o Areas of Cheryl and Barbara Trails
- Request for additional Borough funding of \$500 due to a grant not being available at this time: \*\*\*K. Lundberg moved; D. Patton seconded that \$500 be allocated to the Borough T-N-R Program. Motion passed unanimously.

## **Municipal Building.** Mr. Hazlett provided the following updates:

- Shared an email from Borough Consultant, Amy Kauffman regarding the PA State Budget impasse and the effect on the Borough Grant Request.
- Recommended that the Council schedule a special meeting that would be advertised for public attendance to discuss only the Building Project. Suggested attendees were: Borough Staff, Solicitor, Funding Consultant and Architect along with the Members of Council and the public. It was Mr. Hazlett's request that the Members plan to be in session for as long as it takes to gain the understanding of the project necessary to accept or make changes that would allow the project to move forward at that meeting. Following discussion:
  - B. Carr moved; R. Pyles seconded that a Special Meeting be advertised for Tuesday, February 16, 2016 at 7:00pm for the purpose of discussing the Building Project. Motion passed unanimously.

## **NEW BUSINESS**

**Damage to Jacks Mountain Bridge**. Mr. Fitzsimmons asked if there was a timeline for the re-opening of the Jacks Mountain Road Bridge and if there was an estimated cost for repairs. Mr. Hazlett nor Mayor Harris had been informed by PennDOT as to a timeline for repair. Mr. Hazlett confirmed that the cost to

repair the bridge is the responsibility of PennDOT; explaining that the only obligation that the Borough has is to ½ the maintenance of the Traffic Light.

Mr. Hazlett was asked to provide an update on the meeting regarding the intersection at Rts. 16 and 116. The meeting was well attended; Rep. Moul, several PennDOT officials, local PennDOT supervisors as well as Borough staff. Our concerns were noted; however, no changes are expected at this time. Mr. Hazlett is hoping that the proposed audit of Rt. 116 will include this intersection.
