Janis Ashman, President called the meeting to order at 7:00 P.M. She led the Pledge of Allegiance. The attendance was as follows:

CONSIDERATION OF THE MINUTES OF THE APRIL 12, 2016 REGULAR MEETING

Following brief discussion.

*** D. Patton moved, T. Fitzsimmons seconded, that the minutes of the April 12, 2016 Regular Council meeting be approved as submitted. Motion passed unanimously.

At this time Ms. Ashman acknowledged the large number of citizens in attendance, thanked them for coming and requested that Members consider a change in the agenda to allow discussion of item # 8b regarding the Municipal Building Letting of April 28, 2016 and subsequent discussion be moved to follow public comment. Members agreed by consensus to alter the agenda order whereby Ms. Ashman opened the topic of the new building project with requesting an update from Mr. Hazlett on the bids received and any new information. Mr. Hazlett provided a brief update followed by Mr. Lundberg's update from the building committee which included a mention of a flyer many residents received from an anonymous group claiming that a tax increase is pending to fund the building project.

Following the last public comment Ms. Ashman thanked everyone and asked for a five (5) minute recess; at 9:00pm; Members agreed by consensus to break.

At 9:06pm Ms. Ashman called the meeting back to order.

Ms. Ashman introduced Borough Architect for the Building project, Mr. Benedict Dubs who outlined the project as advertised and reviewed the bids received. Discussion ensued regarding the Alternates and their impact on the base building. Particular consideration was given to Alternate #5 as it dealt with the construction entrance to the project. Mr. Hazlett cautioned that the savings offered by Alternate #5 may not cover the additional cost incurred to repair and maintain the current parking lot caused by the increased heavy construction traffic. Members also voiced safety concerns if construction vehicles were accessing the same entrance as the general public. Following lengthy discussion:

D. Patton moved; K. Lundberg seconded that Council issue a notice of intent to award to Lobar Associates for the base bid of \$3,599,000 plus alternate #4 at no additional cost, with a notice to proceed conditioned upon the use of up to one million dollars in reserve funds, the Architect and Solicitor's review of the contract document submission by Lobar, the execution of a Lease Agreement with the Adams County Library System, and the review and approval by the Solicitor of an agreement for the extension of a water

distribution line with York Water Company. Upon a roll call vote, the motion passed with J. Ashman, R. Pyles, K. Lundberg, D. Patton and S. Skoczen voting yes, and B. Carr and T. Fitzsimmons voting no.

<u>Resolution #8-2016: Additional Considerations for Letting of Contracts.</u> Mr. Wiser explained that the resolution clarified the responsibilities of Borough Staff in the area of notifications of changes to any future incidents of the Letting of Contracts. Following brief discussion:

***K. Lundberg moved; B. Carr seconded that Council adopt Resolution #8-2016 requiring additional considerations for the Letting of Contracts. Motion passed unanimously.

FIRE/EMS/EMA REPORTS

Call Reports were available from Fairfield Fire/EMS and Fountaindale Volunteer Fire Company.

Mr. Carr reported on the Quarterly Municipal Leaders' Forum held at the Fairfield Fire Company. During the meeting Municipal Leaders were asked to provide 3 representatives for a sub-committee to explore volunteerism and the future of the Fire/EMS system as it currently exists. Mr. Carr recommended Mr.

COMMITTEE REPORTS

Planning Commission.

Chairman Ed Kaplan provided the following updates:

- Chapter 27 of the Borough Code of Ordinances was scheduled for review; upon recommendation of Mr. Hazlett, The Commission would like to ask Adams County Planning Office for help with a full review and re-write of this chapter. Mr. Hazlett has identified many areas that appear to contradict other ordinances, many areas have never been reviewed since their inception in the 1970's and the overall organization of the chapter is confusing. Mr. Thaeler from the Adams County Planning Office will be contacted.
- Biking & Hiking Trails full briefing that was prepared for tonight was postponed to June due to the lengthy agenda
- Mr. Kaplan reported on the Home Based Occupation Initiative.
- Mr. Kaplan and Mr. Hazlett reviewed the Request for Proposal for a Consultant to provide a comprehensive re-codification of the Code of Ordinances for the Borough. Following discussion, the Members asked that the document be revised and brought back for action.

ADMINISTRATIVE BUSINESS – BOROUGH MANAGER

Treasurer's Report for April 2016.

Following brief discussion:

*** K. Lundberg moved, B. Carr seconded, that Council accept the March 2016 Treasurer's Report as presented. At this time Mrs. Skoczen stated that Pursuant to Pennsylvania's "Public Official and Employee Ethics Law" (65 PA CSA 1101 et seq), she is abstaining from the motion specific to the check # 29883; payable to Carroll Valley Computes as this is a company that she or an immediate family member has a financial interest and therefore; creating a conflict of interest. Motion passed unanimously with the above noted abstention; a copy of which numbered page 6 and is attached to these minutes.

Request for Use of Pavilion. Ms. Ashman reviewed the email from Mrs. Apryl Huster regarding the use of the Cortner Community Room and Pavilion for a Summer Book Club being sponsored by Fairfield Untied, a local parent group. Mrs. Huster was present and provided an overview of the program and answered questions from Members. Borough Staff confirmed the availability of the pavilion and community room. Following brief discussion:

***D. Patton moved, K. Lundberg seconded that Fairfield United be granted their request to use the Cortner Community Room and Pavilion at no cost for the Summer Reading Program. Motion passed unanimously.

Local Bridge Inspection Program. Mr. Hazlett reviewed the letter received from the Adams County Commissioners regarding this free inspection program. Following brief discussion: *** D. Patton moved; B. Carr seconded that Borough Staff be authorized to sign the Agreement to Participate in the Adams County Bridge Inspection Program. Motion passed unanimously.

Repository Sales Consent. Mr. Hazlett explained that the County has requested that Council take action to allow the sale of those properties on the 2016 Recommended Repository Purchases under Pennsylvania Code 72 P.S. § 5860.205 and further by agreeing; acknowledges that the assessed value to be used for taxation; will be reduced to the purchase price as
