# BOROUGH OF CARROLL VALLEY REORGANIZATION COUNCIL MEETING MONDAY, JANUARY 6, 2020 – 7:00 P.M. BOROUGH OFFICE

#### **MINUTES**

Mayor Ronald J. Harris called the meeting to order at 7:00 P.M and he led the Pledge of Allegiance. The attendance was as follows:

Mayor Harris stated the purpose of the reorganization meeting is to administer the oath of office to the newly elected Borough Council members, to elect a President and Vice President of Council and to appoint and/or reappoint Borough officers, committee members and consultants.

Mayor Harris established that all elected officials had been previously sworn in, the appropriate paperwork had been presented to the Borough Secretary and he congratulated them on their election to the office of Councilor.

### ELECTION OF PRESIDENT AND VICE PRESIDENT

Mayor Harris read the process for electing the President and Vice President. Said process was read from the Borough By-Laws followed by Mayor Harris asking Members via roll call to cast their vote for Council President: The following results were recorded:

Mayor Harris asked each member to cast their vote via roll call for Council Vice President. The following results were recorded:

The vote yielding a majority for Mr. Verderaime.

Mayor Harris turned the meeting over to the Council President Richard Mathews.

Mr. Mathews asked if the By-Laws established the position of President Pro-Tempore; stating that there have been meetings in the past where both he and Mr. Verderaime have been absent and his desire to have established an alternate Member to lead the meeting in such cases. Members agreed that the appointment of a President Pro-Tempore would be appropriate and therefore, following brief discussion:

\*\*\*R. Verderaime moved; B. Carr seconded that Mr. Wight be appointed President Pro-Tempore. Motion passed unanimously.

### ORDINANCES AND RESOLUTIONS

**Resolution #1-2020: 2020 Fee Schedule.** Following brief discussion outlining changes highlighted: \*\*\* R. Verderaime moved; M. Wight seconded that Council adopt Resolution #1-2020: The 2020 Fee Schedule. Motion passed unanimously.

### AFFIRMATIONS OF COMMITTEE STRUCTURE

The Committee structure was affirmed by consensus without discussion.

### APPOINTMENT OF BOROUGH COMMITTEE MEMBERS.

Memorandum dated December 6, 2019 outlined the committee members who have agreed to reappointment; their respective committee affiliation and dates of expiration. Members discussed the various committee seats whose terms were expiring; noting that the Parks, Recreation and Environmental Advisory Committee and the Zoning Hearing Board have seats that will remain vacant due to no one being available for re-appointment. In the case of the Planning Commission; two (2) re-appointments were unable to occur due to requirements of the PA Planning Code for Boroughs; however, Members were presented with new applications for appointment to the Commission for their consideration. Consensus of Members was to address the new applications before acting on the other committees' appointments:

\*\*\*D. Lillard moved; J. Kraft seconded that Sarah Skoczen be appointed to the Planning Commission for a 4-year term to fill the seat #7 vacated by Mr. Michael Wight's term ending. Motion passed unanimously.

\*\*\*D. Lillard moved; J. Kraft seconded that Steven Sites be appointed to the Planning Commission for a 4-year term to fill the seat #8 vacated by Mr. Thomas Schubring's term ending. Motion passed with Mr. Carr, Mrs. Kraft, Mr. Lillard, M. Mathews and Mr. Schubring voting yes; and Mr. Wight and Mr. Verderaime voting no.

\*\*\*B. Carr moved; M. Wight seconded that Owen Phelan be appointed to the Planning Commission for a 4-year term to fill the seat #9 vacated by Mr. Ron Harris's term ending. Motion passed unanimously.

After discussion the following action was taken:

Mr. Hazlett explained that Members would need to accept the resignation and then act separately on the appointment. Following brief discussion:

\*\*\*J. Schubring moved; R. Verderaime seconded that Council accept the resignation of Mr. Carr from the Planning commission. Motion passed unanimously.

\*\*\* B. Carr moved; R. Verderaime seconded that Council appoint L. Michael Wight to the Planning Commission to fill the seat #3 vacated by Mr. Bruce Carr's resignation with a term ending December 31, 2022.
