CONSIDERATION OF THE MINUTES OF THE APRIL 13, 2009 REGULAR FINANCE COMMITTEE MEETING

*** R. Rabenold moved, J. Shay seconded, that the Committee accept the minutes of the Regular Finance Committee Meeting of April 13, 2009 as presented. Motion carried unanimously.

OLD BUSINESS

 $\underline{2009 - \frac{1}{2}}$ Year Review of EIT Collection. Payments from CENTAX have been received frequently which helped the Borough financially during the first 3 months of the year before tax revenues start coming in. The collection rate appears to be on schedule with 51.39% collected as of June 30, 2009.

<u>Act 32 Implementation.</u> Mr. Hazlett updated the members on the Act 32: Countywide Tax Collection progress. He shared a timeline with members stating that as progress is made, he will update the members.

NEW BUSINESS

<u>2009 – Second Quarter Financial Report Review.</u> Comments of the group included those pointing to the economic down-turn as the reason for substantially low receipts in the areas of Property Transfer Tax and Building Permits. Mr. Hazlett stated that he expects to receive approximately 85% of the income projected and will be closely monitoring the expenses and adjusting as necessary.

<u>Property Loan Refinancing Opportunity.</u> Members reviewed an amortization schedule and after careful consideration decided to put this project on hold and possible pursue in 2010.

<u>Street Sweeper Purchase.</u> Mr. Hazlett outlined the request for the capital purchase of an Allianz Johnston VT650 Street Sweeper for \$180,000. Members inquired as to the need for the sweeper. Mr. Hazlett stated that

the maintenance program for the roads involved tar-and-chip which requires the sweeping of excess stone. Research was shared outlining the cost to rent equipment verses the cost to purchase. After discussion: ***W. Reinke moved; R. Rabenold seconded that Finance recommend approval of the purchase of an Allianz Johnston VT650 Street Sweeper for \$180,000. Motion passed unanimously.

<u>Mower Purchase.</u> Mr. Hazlett outlined the request for the capital purchase of a John Deere Z850A 31HP Pro 60" Mid-Z Mower for \$9,495.75. After brief discussion:

***W. Reinke moved; M. Bowman seconded that Finance recommend approval of the purchase of a John Deere Z850A 31HP Pro 60" Mid-Z Mower for \$9,495.75. Motion passed unanimously.

<u>2010 Budget Calendar.</u> Mr. Hazlett shared the calendar with members. Members Bowman, Reinke, Harris and Shay requested an excel copy of the budget upon its release.
