- o Mr. Mathews and other Members expressed concerns over the many problems found in the Document:
 - Typographical Errors
 - Grammatical Errors
 - Missing Words
 - Section References/Cross References Missing
 - Table of Uses is Incomplete
 - Formatting Errors/Issues
 - Pages 47-49: Questioned Preferred Standards
 - "Automobile Traffic": should it specify motorcycles, trucks, bicycles?

Summary Flyer

Members reviewed the Draft Summary Flyer for the Open House. The following comments were considered:

- O Mayor Harris provided a list of Possible Questions that a resident may present, and Members discussed the correct and preferred answers. It was suggested that members highlight the hard work that has been put into it.
- o Condense information to a One-Page document
- o Community Core (CC) should be defined:
 - Mixed-Use District
 - Building to be consistent with Liberty Mountain Resort and Taverna
 - Diversity of Building available (i.e. professional office, multi-family structures, townhomes, etc.)
 - 75% of the designated CC area is Liberty Mountain ski and golf resort
- Members asked Mr. Thaeler where Hamiltonban Township is in their zoning rewrite process:
 - o Planning Commission has had the public meeting and approved a motion to move the document to their Board of Supervisors for consideration
- Rob Thaeler will provide a clean, corrected version of Chapter 27 by 10/01/2019 for review
