#### **OLD BUSINESS**

Zoning Ordinance Amendment Regarding Vacation Rentals & RV Trailer Parking

Members received and reviewed the zoning ordinance that was prepared by Mr. Hazlett. The following item was addressed:

• Under "Definitions" Hard Surface was questioned if the surface must have a minimum overall depth of 6 inches.

Following brief discussion:

#### Proposed Chapter #10 Amendment – Health, Safety, and Nuisances

Members received and reviewed the Proposed Chapter #10 Amendment that was prepared by Mr. Hazlett. Lengthy discussion ensued noting the following:

• Definition of Discarded

- Definition of Attractive Nuisance Replace the current definition with the following: "Attractive nuisance is a dangerous condition on a landowner's property that may particularly attract children onto the land and pose a risk to their safety."
- Section H: Motor Vehicles:
  - o Are Car Ports/Car Tents considered an exception.
- Section H: Enforcement; compliance
  - O Difference between 24 hours' notice and 3 hours' notice. Mr. Hazlett clarified that 24 hours' notice would be if it was a written notice and 3 hours' notice would be if a Police Officer was called out to the property.

Members agreed to review the amendment again at the November meeting.
