## **Chicken Ordinance**

## **Comprehensive Plan**

After lengthy discussion the members asked the borough staff to makes the following corrections:

- In the Vision Statement, paragraph two, second sentence after the word "growth" add "to commercial and residential".
- Page 39, first paragraph, first sentence replace "sets forth" with "guides and delete municipal goals, objectives and policies that guide and leave future growth and development." Second sentence replace "achieved" with "be achieved"; then delete goals, objectives and policies that the plan has identified.
- Page 39, Land Use and Zoning Plan Recommendations paragraph number one under housing add link to Build-out Analysis.

- Page 39, Land Use and Zoning Plan Recommendations eliminate paragraph number two under Housing.
- Page 39, Transportation and Circulation Plan Recommendations, add link to survey results of 2006 and 2009.
- Page 40, Community Services Plan Recommendations, Municipal Services need to get David Hazlett's input.
- Page 41, Fire Department and Ambulance, section to be reworked; should include verbiage that conveys the desire to "seek to become involved in regionalization endeavors".
