# **Comprehensive Plan**

Mr. Hazlett previewed a digital copy of the progress being made to the document. He committed to sending the document in PDF Format via email to Members by Friday, December 9, 2011.

## **Chicken Ordinance**

Following brief discussion, Mr. Hazlett asked that he be permitted to introduce the document and provide the background used in its production. Lengthy discussion ensued after Mr. Hazlett's introduction with the following substantive changes being requested by consensus:

- Section 2-404: restrict the areas available for chickens to areas zoned R-2.
- Remove all reference to requiring permission from neighboring property owners.
- Typo-graphical error in Section 2-412: letter i has the same verbiage as letter k.

\*\*\*D. Lillard moved; R. Harris seconded that Members recommend to Borough Council the adoption of the Proposed Ordinance amending chapter 2 of the Code of Ordinance to permit the limited keeping of domesticated chickens on residentially zoned property with the changes agreed upon by the Commission. Motion failed for lack of a majority vote having yielded three (3) yes votes from M. Davidson, R. Harris and D. Lillard and three (3) no votes from L. McLeod-Simmons, N. Abrams and E. Kaplan.

Discussion continued with Mr. Abrams stating that he would consider reversing his no-vote with the understanding that as a Councilman, when discussion is heard at Council, he will opine that the ordinance could be written differently and further that he may not vote in the affirmative at the Council level.

\*\*\*D. Lillard moved; M. Davidson seconded that Members recommend to Borough Council the adoption of the Proposed Ordinance amending chapter 2 of the Code of Ordinance to permit the limited keeping of domesticated chickens on residentially zoned property with the changes agreed upon by the Commission. Motion carried with L. McLeod-Simmons and E. Kaplan casting no votes.
