## **OLD BUSINESS**

## Amendment to Carroll Valley Borough Zoning Ordinance - Eluma, Inc.

Charles Suhr, Attorney with Steven's & Lee, representing Eluma, Inc. outlined the revisions to their proposed changes to the zoning ordinance as discussed at last month's meeting. Following discussion; Mr. Suhr agreed to attend the December meeting and provide:

- Revisions to proposed Zoning Ordinance:
  - Section 7 Item D: Add verbiage "for a period not to exceed 5 additional years"
  - o Section 8: Add verbiage "Individual private well and individual on-site sewage systems are not considered 'public'"
  - o Section 16 (Table 27-D): Increase the "Green Area buffer from adjacent residential uses outside the Cluster Development Parent Tract" to 100'
- Provide definitions and detailed description of a "Buffer" to include "Vegetative Screen"
- Prepare a briefing that could be delivered to Borough Council and Residents that would concisely and accurately describe the zoning change with descriptions and examples of a Cluster Community

#### **NEW BUSINESS**

**Consider Application of John Schubring to fill vacancy on the Commission.** Members reviewed the Application of Mr. John Schubring, 10 Green Trail, Carroll Valley for recommendation to Council for appointment to the Vacant seat on the Commission. Mr. Schubring was present and answered questions. Following brief discussion: \*\*\*R. Harris moved; R. Verderaime seconded the appointment of Mr. John Schubring, 10 Green Trail, Carroll Valley be recommended to Borough Council for the Vacant Seat on the Borough Planning Commission. Motion carried unanimously.
