NEW BUSINESS

Proposal of Trade Lots: Mr. Hazlett outlined four (4) requested trades submitted by a land owner. In each case the lot requested for trade would be re-combined with an adjacent lot already owned by the requesting land-owner. Members discussed each proposal and decided that the 3rd and 4th

were not in the best interest of the Borough and the remaining two (2) were questioned as to whether the lots acquired would be eligible for tax exemption. Mr. Hazlett will contact the Adams County Assessment Office regarding their eligibility and the Proposals were tabled until next month.
