OLD BUSINESS

Comprehensive Ordinance Review.

Chapter 10: Health and Safety: Mr. Kaplan introduced the topic; Mr. Hazlett reported that complaints are received each year involving unlicensed or unregistered vehicles on properties throughout the Borough. Current ordinances state that unless the vehicle is deemed "unsafe" or a "hazard"; it can remain on the property. After lengthy discussion the following concerns were voiced:

- Consider a definition of "storage".
- Consider a definition of "abandoned"
- Is there a need and does the Borough want to regulate an "Eye Sore"? If so, objective, measurable criteria need to be established so as not to impede personal taste/decor.
- §10 Part 1: struck in its entirety. Dissolution of Board via Ordinance 1-2011
- \$10-202 clarify the definition of "motor vehicle"; consider a list of inclusions or exclusions; i.e. boats, jet skis, golf carts etc.
- §10-203 clarify "plain view". Consider the view from "the street" and the view from "the neighbor" and is the use of tarps improving the view.
- §10-205 & 206 add language to include "vehicles"
- §10-209 strike in its entirety
 - Procedural questions: Upon issuance of a Citation: If a hearing is requested and held; and Council overrides the Zoning Officer; what happens?
 - Citation is pulled by zoning officer?
 - Zoning Officer fails to show in court?
 - Other options?

Borough staff was asked to compile sample ordinances that addressed the unregistered vehicle issue differently. The issue was tabled until the next meeting.

Working Group: Home Office/Home-Based Businesses.

Mr. Kaplan reported that the group did not meet and reminded staff that they would like a list of businesses permitted in the Borough. Following their next meeting a report will be shared.
