CONSIDERATION OF THE MINUTES OF THE JULY 5, 2016 PLANNING COMMISSION MEETING

PLANNING COMMISSION MEMBERS

OLD BUSINESS

Comprehensive Ordinance Review.

Mr. Kaplan shared that Council agreed to engage the Adams County Planning Office to act as consultant for the re-write of Chapter 27: Zoning of the Borough Code of Ordinances. The County has not assigned the staff to our project yet but hope to have everyone in place by the October meeting. Additional discussion ensued regarding the South West Adams Regional Planning Document and its possible impact on the Zoning Ordinance Review. Mr. Kaplan suggested a meeting of the original stakeholders be considered to discuss goals for the area.

Working Group: Home Office/Home-Based Businesses. No new report

Hiking/Biking Trails.

Ms. Davidson shared that the Borough is negotiating with Eluma Corporation for land use/acquisition for the proposed trail.

Adams County Planning.

No new report.

NEW BUSINESS

Mayor Harris addressed Members at the request of a resident who could not attend regarding the keeping of chickens in the Borough. The following topics were discussed:

- Clarity of Borough Ordinance
- Deed Restriction vs Ordinance

- Zoning Districts Is it time to change the map? Is there room for chickens?
- Can a Borough Ordinance Supersede a Deed Restriction?
- Can Deed Restrictions be removed?

Mr. Pyles opened a discussion about building requirements for new homes which led to the following issues being discussed:

- # of Building Permits issued since 2005
- # of Restrictions on Building
- Permitting Requirements of the Borough vs those of neighboring municipalities
- Should Zoning Ordinances encourage growth? If so, does the Borough's?
- Sprinklers
 - o Pro's and Con's Mr. Kaplan provided statistical data
 - Cost? Is it inhibitive? Is it worth the risk?
- Suggestion to Invite Local Contractors to a meeting to get their perspective

Ms. Marthers reported that Council has requested a written summary of each committees' meeting be provided for their Council Packet. Council expressed concern that they have little time to process and evaluate information that is provided verbally during a meeting and would like the opportunity to review the information prior to the public meeting. Attendance at Council Meetings by committee members is still encouraged and Council acknowledges that that additional information or clarification can come from the committee liaison during the meeting. Following brief discussion, Mr. Kaplan agreed to have a short written summary prepared by the deadline (Thursday prior to a Council Meeting) following each Commission meeting and further stated that he would continue attending the Council meetings as well.
