CONSIDERATION OF THE MINUTES OF THE DECEMBER 5, 2016 PLANNING COMMISSION MEETING

***L. McLeod-Simmons moved, E. Kaplan seconded, that the Commission accept the minutes of the Planning Commission Meeting of December 5, 2016 as submitted.

OPEN TO THE PUBLIC

Review of Sprinkler Ordinance – Fire Company Personnel

The following citizens addressed the Commission at this time:

- William Jacobs, Chief, Fairfield Fire & EMS addressed the commission. Mr. Jacobs stated that Pennsylvania is the 3rd highest in the country for fire related deaths. He stated that the fire departments can't beat the fire timeline due to roads and water supply. He showed examples of how wood used to build homes has changed over the years.
- Ed Bowman, Safety Officer, Fairfield Fire & EMS addressed the commission. Mr. Bowman stated that the problem with home fires are; the types of materials that are used during the construction of the home, resources, and water supply. He expressed that sprinkler systems are 96% effective and for a single family home it costs around \$5,000.00 to have a system put in.
- Bruce Carr, 92 Eagle Trail, Carroll Valley Resident addressed the commission. He stated that he believes that the sprinkler system should be personal choice.
- Ed Kaplan, Planning Commission Member addressed the commission. He stated that the high risks are increasing and firefighters are decreasing.
- Dave Martin, Chief, Fountaindale Fire Company addressed the commission. He stated that it is a life safety issue.
- Frank Buhrman, 4 Crossland Trail, Carroll Valley Resident addressed the commission. He stated that he was in support of the sprinkler ordinance.
- Robert Verderaime, Planning Commission Member addressed the commission. He went over the pros and cons of the sprinkler ordinance.
- Ron Harris, Planning Commission Member addressed the commission. He gave a brief overview of the cost of a sprinkler system.

• Wayne Powell, Vigilant Hose Fire Company addressed the commission. He stated that it is 7 miles from Emmitsburg to Fairfield to help with a house fire. He also stated that Alabama and Mississippi are the two worst states for fires.

After lengthy discussion the following action was taken:

***R. Verderaime moved; E. Kaplan seconded that the Commission recommend that Council not repeal the sprinkler ordinance. Motion passed with R. Tyler Pyles voting no.
