RESOLUTION NO. 13-2023

A RESOLUTION OF THE BOROUGH OF CARROLL VALLEY, ADAMS COUNTY, PENNSYLVANIA <u>ESTABLISHING NEW SANITARY SEWER RATES</u>

WHEREAS, the Borough of Carroll Valley (the "Borough") has determined that an increase in the charges for sanitary sewer service rates is necessary to meet the actual and anticipated expense of the Borough; and

WHEREAS, Section 1202(2) of the Borough Code authorizes the Borough to make and regulate charges for its utilities for general borough purposes; and

WHEREAS, Section 1202(5) of the Borough Code authorizes the Borough to make regulations as may be necessary for the health, safety, morals, general welfare and cleanliness and beauty, convenience, comfort and safety of the Borough; and

WHEREAS, in accordance with Section 2061 of the Borough Code, the Borough has adopted an ordinance, found in Chapter 18 of the Code of the Borough of Carroll Valley, providing for the imposition of sewer rentals or charges; and

WHEREAS, the Borough may fix, alter, change and collect sanitary sewer rates and other charges in the area served by its facilities at reasonable and uniform rates to be determined exclusively by it, for the purpose of providing for the payment of the expenses of the Borough, and for the improvement, repair, maintenance, and operation of its sanitary facilities.

NOW THEREFORE, BE IT RESOLVED and it is hereby RESOLVED, by the Council of the Borough of Carroll Valley, Adams County, Pennsylvania, that the sewer rates set forth below are hereby fixed as follows to be effective and applicable to sewer service for which a bill is issued on or after January 1, 2024:

ResidentialPrivate Dwelling Unit, Flat Rate, Quarterly Rate\$217.00/quarterNon-Residential Non-metered\$308.25/quarterCommercial or Short-Term Rental Dwelling Unit\$308.25/quarterFlat Rate, Quarterly Rate\$308.25/quarterNon-Residential\$112.50 (minimum)First 3,000 Gallons Per Month\$112.50 (minimum)For flow in excess of 3,000 gallons per month\$0.0375 per gallon

First 1,000 Gallons Pumped Per Pumping (Mandatory twice per month)	\$55.15 (minimum)
Amount pumped in excess of 1,000 gallons per pumping	\$0.05515 per gallon
