- Property owner is responsible for determining if property is subject to private covenants and/or subdivision and land development regulations or private plan restrictions and compliance with the restrictions. Private covenants may be more restrictive than zoning regulations. Issuance of a building or zoning permit does not constitute compliance with private covenants or restrictions. Any legal controversies arising from a permit issued in violation of any private covenants or restrictions is the sole responsibility of the property owner or their authorized representative.
- Property owner is responsible for securing the proper location of property lines and guaranteeing the proper set-back requirements are met throughout the project. The Borough of Carroll Valley reserves the right to require a Foundation Certification, As-Built Plans and/or a Certified Survey of the Property in order to verify set-back requirements.
- Property owner or their representative is responsible for supplying the Borough of Carroll Valley with a copy of Water Well Information Report upon completion of the drilling. By completing this required reporting to the PA Department of Conservation & Natural Resources and the submission of the Report to the Borough; The Property Owner agrees that the well installed meets all requirements and regulations of the Commonwealth of PA and the Borough of Carroll Valley.

STATEMENTS AND VERIFICATION BY APPLICANT
